#### Save The Date - Upcoming Historical Society Meeting

King & Queen County Historical Society Meeting - Sunday, January 26, 2025 at 3:00 p.m. in the Court House Administration Building, King and Queen CH, VA 23085. Richard Carter, formerly with the Smithsonian Institution, will speak on the care and preservation of Historical Federal government buildings in Washington, D.C. He will also touch on the care and preservation of the Virginia Capitol and the Executive Mansion in Richmond.

Mr. Carter worked for years at the Smithsonian's National Portrait Gallery and the National Museum of American Art. Both museums occupy the building called "The Old Patent Office." He later worked at the National Endowment for the Humanities, located in the building called "The Old Post Office." In Richmond, he served a five-year term on the board that oversees the Executive Mansion. Mr. Carter is a writer and editor in Essex County.

#### Interpretive Signs for the Courthouse Green Historic District

In September 1998, the King and Queen Courthouse Green Historic District was added to the National Register of Historic Places. Located at King and Queen Court House VA, the area is a wonderful place to take a stroll through history. In fall 2024 three interpretive signs were placed around the District to narrate an account of the colonial courthouse and the village that grew up

around it. Photographs, drawings, brief historical notes, and quotes from early visitors and local residents tell the story.

"There are seven buildings in the district... the old courthouse. the old clerk's office, the old county jail, and four other buildings which relate to the activities of a typical rural courthouse community. including a former hotel and tavern building, a former school building, a former specialty store building and a residence on the site of another hotel/tavern. This district has remained largely intact up to this time, possibly because of its rural and isolated location."

Immanuel Episcopal Church and cemetery were later included in the district. *Historical Society Bulletin #85, July 1998*, "King and Queen Courthouse Green Historic District."

## October 2024 Historical Society Meeting Held at "Smithfield"

Annually at its October meeting the King & Queen County Historical Society meets at a historic location in the county. On Sunday, October 27, 2024 the meeting was held at "Smithfield", built in 1781 by William Hill, near St. Stephen's Church VA. According to the book *Old Houses of King and Queen County, Virginia* the property has been called "Smithfield" since the 18th century (origin of the name unknown), many years before James Smith became the owner in 1832. The current owner is a Smith descendant. Richard Rumrill, James Smith's 3rd great grandson talked about stabilization and reanimation work done on the house and its dependencies. The attendees were invited to tour the large house, dependencies, and grounds.

#### The "America 250 Quilt"

The Henricopolis Chapter of the Daughters of the American Revolution (DAR) began celebrating the upcoming 250th Anniversary of the United States in 2024. They created a vibrant guilted wall hanging to tell of the contributions made by the historic counties represented in the Chapter: Essex, Hanover, Henrico, King & Queen, King William, Lancaster, Northumberland, Richmond, Westmoreland. It is approximately 50"x50" with a 12"x12" ink transfer block within a star for each of the nine counties. Each square features an historic person, place, or event in one of these nine counties and calls attention to the sacrifices patriots made to ensure our country's freedom. Accompanying the quilt is a notebook with an image of each block and a text of its meaning. Museum volunteers Dawn Shank and Page McLemore, designed the image and wrote the text for the King & Queen County block positioned in the upper right corner. The quilt was a featured exhibit at the Courthouse Tavern Museum 2024 Holiday Open House. At this time it has been exhibited at least once in each of the nine counties. On March 15, 2025 it will be returning to King and Queen County for the K&Q Quilt Show at the King & Queen Public Library in St. Stephens. Because the quilt needs a home, DAR chapter members decided the only fair way to choose a recipient was to have a drawing. "Voices" (DAR-speak for tickets) will be sold and the drawing will be held at the DAR annual recognition meeting on May 17, 2025.
